

Ivar's Dinner & Seawolves Tickets Official Sweepstakes Rules

1. No purchase necessary. Must be a WA State resident 18 years or older to enter. To submit a single entry, electronically, fill out a form at Ivars.com. Entries will be received continuously starting February 15, 2019 through May 22, 2019. Entries received after the end date are void and will not be included in the drawing.
2. Winners will be selected in a random weekly drawing. Winners will be notified by phone or email within one (1) day of the drawing date. Drawing will be random and conducted by Ivar's, Inc. whose decision in all matters is final. Odds of winning any prize depends on the number of valid entries.
