

Ivar's Teacher of the Year Official Rules

1. No Purchase Necessary. To enter, write an essay on why this teacher should be Ivar's Teacher of the Year and drop off or mail to any participating Western Washington Ivar's locations. Entries may also be submitted electronically via Ivar's Teacher of the Year subpage at www.ivars.com/teacher. One entry per person only. Entries must be received by May 19, 2017. Entries received after this date are void and will not be included.

2. Winners will be selected on or about May 31, 2017. Winners will be notified by phone or email within 7 days of the actual selection date. Selection will be conducted by Ivar's whose decisions in all matters relating to the contest are final.

3. Grand Prize: One (1) teacher will receive a \$500 Gift Card for school supplies to a store of their choice (ARV \$500). **First Prize:** Two (2) teachers will each receive a \$150 Gift Card for school supplies of their choice (ARV \$300). **Second Prize:** Fifteen (15) teachers will each receive a \$25 Ivar's Gift Card (ARV \$375).

Judging of art based upon whether it complements or highlights a well written essay. Art cannot be submitted in lieu of essay.

6. General: By participating, entrants acknowledge and agree to be bound by these rules and the decisions of the judges as final. By participating, entrants consent to the use of names and/or likenesses by Ivar's for the purpose of advertising without limitation or compensation.
